- ² The Legislature failed to elect a Senator for the term beginning March 4, 1899, until February 7, 1900. Seated March 5, 1900.
- ³ Died in office September 16, 1859. Mortally wounded in a duel by David S. Terry, Chief Justice, California Supreme Court.
- ⁴ Appointed to fill the vacancy caused by the death of Dianne Feinstein. Seated October 3, 2023.
- ⁵ Resigned from office November 29, 1873.
- ⁶ Also served as a Member of the U.S. House of Representatives from California.
- ⁷ Elected as Douglas Democrat but later changed to Union Republican.
- ⁸ Resigned from office November 30, 1950.
- ⁹ Died in office July 30, 1964. Also served as a Member of the U.S. House of Representatives from California.
- ¹⁰ Seated November 10, 1992. Died in office September 29, 2023.
- ¹¹ Elected to fill the vacancy caused by the death of George Hart. Seated December 7, 1891. Also served as a Member of the U.S. House of Representatives from California.
